THE GAMING (AMENDMENT) REGULATIONS, 2009

Citation

G.N.No.385  
of 2003

1. These Regulations may be cited as the Gaming (Amendment) Regulations, 2009, and shall be read as one with the Gaming Regulations, 2003, hereinafter referred to as the Principal Regulations.

2.-(1) The Principal Regulations are amended by:

(a) adding immediately after regulation 67 the following new regulations:

“Application  
of forty  
machines  
Site licence

67A.-(1) The applicant shall, where the application is for forty machines site licence, submit to the Board an application in appropriate prescribed form set out in the Schedule to these Regulations. .

(2) The application form referred in subregulation (1) shall be in duplicate.

(3) The Board shall, where it is satisfied that the application meets all the requirements specified in the Act and these Regulations, issue to the applicant a forty machines site licence in the format set out in the Schedule to these Regulations.

(4) Application for a forty machines site licence shall include details of the premises intended to be used and be subjected to approval of the Board.

(5) The Board shall approve the premises after being satisfied that the same meets the requirements specified by the Board.

Premises

**67B.**-(1) The licensee shall, where the premises are not owned by him, enter into a written agreement with the owner of the approved gaming premises, to place the forty machines for play at the approved gaming premises, such agreement shall be submitted to the Board for notification.

(2) Subject to the provisions of regulation 19, in case the forty machines site is located in Dar es Salaam, the premises for a forty machines site shall be at least five hundred meters in radius away from the premises of casino, and at least two hundred meters in radius away, where the forty machines site is located in the area other than Dar es Salaam.

(3) The holder of forty machines site licence shall be authorized to place and operate the machines in the approved premises.

Provisions relating to classification, licensing and termination of employees

**67C.** The provisions of regulations 28 to 36 shall be applied in relation to classification, licensing and termination of employees of forty machines.

Stakes and prizes for forty machines

**67D.** The Stake and Prizes Placed for forty machines site shall be subject to the requirements provided under Regulation 38 of these Regulations.

Requirement and surveillance system in casino

**67E.**-(1) The holder of a forty machines site licence shall be required to install, maintain and operate at all the time surveillance system comprised of cameras, monitors, video tape recorders, digital recorders and the video printer that provides the coverage approved by the Board.

(2) The provisions of regulations 44 to 48 shall also apply to the holder of a forty machines site licence.

(3) The holder of a forty machines site licence shall be required to install, maintain and use gaming management system in the operations.

Licensee to have a meter for each jackpot

**67F.-(1)** Every licensee of forty machines site licence conducting progressive, mystery or jackpot systems, shall have a meter for each jackpot which shows the amount of the progressive or mystery jackpot displayed conspicuously at or near the game which the jackpot applies.

(2) A licensee shall not reduce the amount displayed on the progressive or mystery jackpot meter or otherwise reduce, eliminate progressive or mystery jackpot, unless a player wins the respective jackpot.

Approved premises

**67G.-(1)** The licensee of forty machines site shall at all the time, maintain the operation of forty machines in one approved premises.

(2) The holder of forty machines site licence shall not conduct any games other than slot machines in the approved premises unless has applied and obtained the approval of the Board.

(b) by adding immediately after item 21 of the First Schedule the following new items:
