## THE GAMING (AMENDMENT) REGULATIONS, 2010

Citation

G.N.No.385 of 2003 1. These Regulations may be cited as the Gaming (Amendment) Regulations, 2010, and shall be read as one with the Gaming Regulations 2003, hereinafter referred to as the principal Regulations.

Amendment of the principal Regulations 2. The principal Regulations is hereby amended by deleting the First Schedule and replacing it with following new Schedule:
