The *Gaming Board of Tanzania* now invites sealed Tenders from eligible *national* contractors registered or capable of being registered in building **Class III and above** for carrying out the **Proposed Office Fitouts & Interior Works at 27th Floor PSPF Towers Dar es Salaam for Gaming Board of Tanzania**

Tendering will be conducted through the **National Competitive Bidding** procedures specified in the Procurement Regulations, 2013 - Government Notice No.446 as amended in Public Procurement (Amendment), Regulation, 2016 Government Notice No.333 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
5. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the

Tender Board at *Gaming Board of Tanzania, 3rd Floor, Harbour View Towers, Samora Avenue, Dar es Salaam, Tanzania* from **09:00 am to 16:00 pm working hours** on Mondays to Fridays inclusive except on public holidays.

A complete set of Tendering Document(s) in *English* and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **TZS 150,000/=** Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **Director General deposited on Account No.012103016135 at National Bank of Commerce, Samora Avenue Branch**
7. All Tenders must be accompanied by a Tender security in an acceptable form in the amount of **2% Of Tender Price** or freely convertible currencies in case of foreign Tenderers.
8. Site visit and Pre-bid meeting shall be conducted on Tuesday 8th May 2018 at 10.00am

All Tenders in one original plus *Three* properly filled in, and enclosed in plain envelopes must be delivered to the address at **Secretary to the Tender Board, Gaming Board of Tanzania, 3rd Floor, Harbour View Towers, Samora Avenue, Dar es Salaam, Tanzania** at or before **Tuesday, 15th May 2018, 10.00 am**.
